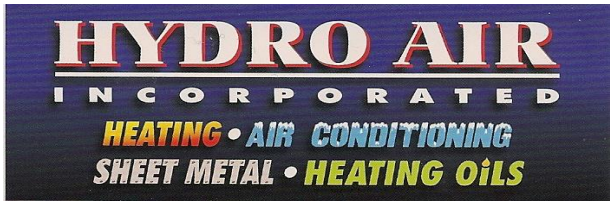

**A. Commitment Contract:**

In the event gallons remain on your contract after 4/30/2024. Hydro Air Inc. will deliver the remaining gallons to the address on this contract automatically at the daily posted price. There is no downside protection offered.

**B. Budget Contract:**

This contract is to “budget” \_\_\_\_\_ gallons of heating fuel @ **\$3.989 per gallon**. Budget term is eight (8) months from 09/01/23 to 4/30/24. Once you have determined gallons needed, we will calculate your monthly payment.

\*\*\*\* A minimum of 500 gallons of heating fuel is required for all contracts \*\*\*\*

\*\*\*\* All automatic deliveries will be delivered at our discretion to the address pertaining to this contract \*\*\*\*

\*\*\*\* If all gallons are used before the expiration date of this contract Hydro Air Inc. will continue to automatically deliver at daily posted price until end of contract date \*\*\*\*
